Re: LORGE FOR WISCONSIN LT GOVERNOR: MAKE WISCONSIN TAX FREE FOR BUSINESS

Lt. Governor Candidate Robert Gerald Lorge announced his proposal to **make Wisconsin 100% Tax Free For All Businesses** following the Dane County Republican picnic yesterday at Bishop's Bay, Madison, Wisconsin:

"Right now Businesses are struggling, big businesses are leaving Wisconsin and America, Small businesses are closing down or moving out of the State of Wisconsin, especially in small towns and cities all across Wisconsin," Lorge said. "Wisconsin needs to attract business and not chase them out or chase them down by taxing them to death and regulating them to death."

The LORGE PLAN FOR A TAX FREE WISCONSIN BUSINESS CLIMATE: Completely abolish **ALL** business income taxes for all Wisconsin based Corporations, Partnerships, Limited Liability Companies (LLCs), Farms, Family businesses, sole proprietorships, as long as the business meets these three criteria:

1. The Business is (or becomes) a Wisconsin based business (any entity, any form, incorporated or not);
2. All otherwise taxable income, cash inflows and receipts are deposited into a Wisconsin bank, credit union, Savings and Loan, or other Wisconsin lending or financial institution;
3. The funds in that Wisconsin Business account are used for business purposes.

"The latest available statistics in 2008 according to the Small Business Administration states that there are 29.6 million businesses in the United States, yet only 51% of new firms survive for 5 years, high taxes in Wisconsin explains why Wisconsin does not have it's share of these businesses", Wisconsin's Next Lt. Governor Robert Gerald Lorge pointed out.

"Wisconsin has 406,766 small businesses, and 311,994 Self-Employed (Schedule C) Individual Small Business Owners and Entrepreneurs, who provide over 85% of all new Jobs and employment in the State of Wisconsin," Lorge said. "With the rise of the Internet, and modern shipping, import/export distribution channels, Wisconsin's high taxes and red tape is presently killing our business climate, we are losing businesses and with them high quality paying jobs to places like Illinois just across the border, or across other borders like to Communist China or Mexico. Wisconsin's average Income is \$37,700 while right over in Minnesota it is \$42,900, my job as Wisconsin's Next Lt. Governor is to improve our economy so that we get at least that \$5,200 pay increase and bringing more business into Wisconsin is the way to do that." Robert Gerald Lorge explained.

"Imagine large multi-national corporations flocking INTO WISCONSIN instead of the reverse, and small businesses and new high tech businesses and their owners coming here, to escape taxes from other higher tax states. If we MAKE WISCONSIN THE FIRST STATE TO GET TO ZERO TAXES, we will have businesses lining up the highways to get here, the same way that Florida and other States are robbing us of our retired senior citizens, pensioners and high income executive class right now, they tell me they can not afford to stay in Wisconsin when Florida has NO income taxes!" Exclaimed Lorge.

"Wisconsin will well make up for 'letting go' of taxing businesses, by keeping that money here in Wisconsin to grow businesses and grow jobs, why the banking inflows alone will provide so much capital in Wisconsin that our own home mortgages, car loans and most importantly business loan interest rates will be the lowest in the Nation." Lorge stated. "Wisconsin must use economic common sense and allow the economic multiplier effect to rebuild Wisconsin, we will make up the lost revenues on the flip side, the harvest side, when Business Owners AND NOT THE GOVERNMENT decide it is time to take profits out of the business, in the meantime we reap the benefits of GROWTH!" Robert Gerald Lorge concluded, as he headed off to another campaign event in Milwaukee.
